**Tabling Statement**

Under section 72 of the *Public Governance, Performance and Accountability Act 2013* (PGPA Act), responsible Ministers are required to table information regarding relevant events relating to company or share transactions by their non-corporate or corporate Commonwealth entities.

Relevant s 72 PGPA Act events from the Commonwealth Scientific and Industrial Research Organisation (CSIRO), a corporate Commonwealth entity in my portfolio, are below.

I note that many of these events relate to transactions that occurred some time ago as a consequence of CSIRO continuing the historical practice of batch submissions, resulting in a delay in notifying my Office. I have spoken to the Chief Executive of CSIRO in relation to the delays in the relevant information being provided to me as responsible Minister. I have conveyed my expectation that these matters must be reported to me in a much timelier way. CSIRO has worked closely with my Office to improve its processes so that future notifications of s72 events are undertaken in a timely manner in accordance with the PGPA Act.
